Tournament Schedule

Participants will shoot at one of three times available, 8 AM, 12:30 PM, or 4:00 PM. Shooting will begin at these times with two practice ends. Awards will be presented following 4:00 line. Room is limited on each line, please get your registration in early to receive first choice. Tournament director will contact you with confirmation you have received your chosen time slot.

Tournament Format

Archers will score 60 arrows, 20 ends of 3 arrows each. Senior, Junior and Cadet Divisions have a choice of either a 40cm single target face or a 40cm triangle 3 spot. Cub, Bowman and Yeoman Divisions will shoot a 60cm target face.

Fee

The fee for the tournament will be \$20 per archer, for a maximum of \$40 per family. Please submit family registration forms together.

No refund given for cancellations received after November 21. Form must be postmarked by November 21, 2005.

Late registrations and walk-ins will be accepted on a space available basis only, if your form is not postmarked on time you will not be guaranteed a space!
