Waivers

The USA Archery waiver and Kennesaw Archery waiver are valid for one year or expiration date noted on waivers. Each individual or family member must complete the waivers prior using the range.

Youth Archers

For your child's safety, a parent or adult guardian (18 years or older) must be present anytime a youth is at the range. If a minor has driven to the field, they do not need a parent or guardian present. There is no exception to this safety rule!

Orientation

All archers must complete a one-time orientation \$20. Participants learn archery basics, as well as archery and range safety. Go to www.kennesawarchery.com to sign up for orientation. We have orientation classes once a month. Orientation classes fill up fast, so register early. If you are waitlisted, your name will be placed at the top of the next orientation list in the order of sign-up. Walk-ins are not accepted since space is limited.

USA Archery Membership

USA Archery Membership is required for all recreational archers and KAC members. Go to www.teamusa.org/USA-Archery/Membership to apply. Please select Kennesaw Archery Club as your affiliated club.

If you are filling out these waiver because you are taking Orientation, you will be able to take orientation without becoming a USA Archery member. However, you **MUST** join USA Archery by your 3rd Saturday Range visit. For example, you may take an orientation class followed by 2 range visits, then you must become a USA Archery member before your 3rd range visit.

USA Archery Membership Levels

Recreational

Basic membership level: not eligible to participate in USA Archery sanctioned competitions, Junior Olympic Archery Development (JOAD), and Adult Archery Program (AAP).

Youth, Adult, Family, Lifetime

Full membership level required to enter USA Archery sanctioned competitions or to participate in Junior Olympic Archery Development (JOAD) and Adult Archery Program (AAP).

Frequently asked questions:

Can I leave my minor child at the field during range hours? **No.** For your child's safety, a parent or adult (18 years or older) guardian must be present anytime a minor is at the range. If a driving age minor has driven to the field, they do not need a parent or guardian present. There is no exception to this safety rule!

Can I stand on the shooting line or walk to the target with my child? **No.** For your safety, you must remain behind the shooting line in the viewing area at all times, even when arrows are being retrieved from the target. If you wish to accompany your child on the shooting line or to retrieve the arrows, then you will need to take the orientation class and become a USA Archery member, as well as pay the \$5 Saturday morning range fee. There is no exception to this safety rule!

Do I need to become a member of USA Archery? **Yes.** All archers, both KAC members and recreational archers must become members of USA Archery by their 3rd visit to the range. The USA Archery membership can be completed through the USA Archery website -- www.teamusa.org/USA-Archery/Membership. Please select Kennesaw Archery as your club affiliation. **Kennesaw Archery Club Members** or recreational archers must be Recreational, Youth, Adult, Family, or Lifetime USA Archery members. **SOAD and JOAD Members** must be Youth, Adult, Family, or Lifetime members of USA Archery to be eligible to earn S/JOAD Star Pins. USA Archery Recreational member are not eligible to earn S/JOAD Star Pins.

Do I need to attend the KAC orientation session before I can use the field or attend lessons? **Yes.** Archers learn the basics needed to begin lessons. More importantly, the archers learn about range and archery safety. Class size is limited, so sign up early. If you are wait listed, your name will automatically be added to the top of the next orientation class list.

Do you accept "walk-ins" for orientation sessions? **No.** Because of limited space, we do not accept walk-ins for orientation.

Do I need to be a KAC member to attend lessons? **No.** However, you will need to be a USA Archery member.

How do I get on the Kennesaw Archery Club email list? Go to kennesawarchery.com, scroll to the bottom of the page where you will see "Subscribe to our weekly mailing list." After you subscribe, you will receive a verification email. You will be added to the KAC email list once you have replied to the verification. Kennesaw Archery club sends out 1 email each week regarding the upcoming Saturday lessons. At times, we may send out an additional email with important announcements such as membership information or range safety. We do not share your email with club members or share you email address to any outside organization.

Do I need to sign the KAC and the USA Archery waivers each membership year? **Yes.** The USA Archery waiver and the Kennesaw Archery waiver and Photo Release form are valid July 1 thru June 30 each membership year. Therefore, a new waivers need to be signed each membership year.

Do you accept credit cards? **No.** We accept cash (exact change please) and checks. KAC will charge \$25 + check value for returned checks.

How do I become a Kennesaw Archery Club member?

Apply at the outdoor or indoor range during Saturday morning range hours.

What do I need to turn in to become a member of Kennesaw Archery Club, AAP (SOAD), or JOAD?

1. Completed membership application
2. Copy of your current USA-Archery membership card
3. Completed KAC Waiver with Photo Release form
4. Completed USA Waiver
5. Payment (including out of Non-Cobb County Resident fee if applicable)

Who needs to pay the Non-Cobb County Resident? If you live in any county other than Cobb County, the Cobb County Parks and Recreation Department charges a \$25 fee for use of their property. Any person/family joining Kennesaw Archery Club, JOAD, or SOAD who lives out of county will need to pay the \$25 fee.

When will I receive my membership card and gate code to the outdoor range? Once the 5 items that are listed above have been received and your county address has been verified, the KAC membership card with the gate code will be given to you at the field. If you are applying by mail, your membership card and the gate code will be emailed to you.

Do I receive the gate code if I am only a AAP (SOAD) or JOAD member? No, you must be a full Kennesaw Archery Club member to receive the gate code.

Can my membership be prorated since I am joining late in the membership year? Yes and no. The KAC membership fee can be prorated. The Non-Cobb County Resident fee, the AAP (SOAD) membership fee, and the JOAD membership fee cannot be prorated.

Is rental equipment available and How much are Saturday morning lessons? Equipment is available for rental during Saturday morning field hours only. There is a \$5 per visit equipment rental fee. The fee is charged for using any of the equipment. For example, if you have your own bow, but need to borrow arrows, the \$5 rental fee needs to be paid. Saturday morning group lessons are \$5 per visit.

The risk of injury from archery and other known and unknown events and activities and/or the use of the related buildings, structures, equipment, automobiles, firearms, weapons, ATV's, boats, tree stands, roads, bodies of water, land and all other real and personal property whether owned by Kennesaw Archery Club, instructor(s), or others is significant, including potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and

I acknowledge and agree that the use of archery equipment, and other weapons by myself or others on any Kennesaw Archery Club range, Cobb County Department of Parks and Recreation property, and other property used for training, classes, events, and activities, are inherently dangerous and high risk activities whether such archery equipment, or weapons are discharged by myself or others; and
3. I KNOWINGLY AND **FREELEY** ASSUME ALL SUCH RISKS, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others, and assume full responsibility for my participation; and
4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS** Kennesaw Archery Club, Inc., its officers, instructors, directors, officials, agents, employees, volunteers, members, guests, other participants, sponsoring agencies, sponsors, advertisers, Cobb County Department of Parks and Recreation, and if applicable, owners, and lessors of real property and personal property used to conduct the events and activities ("RELEASEES"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.**

I understand the nature of archery activities and acknowledge my experience and capabilities and believe I am qualified to engage in and conduct the Activity. I further acknowledge that I am aware that the Activity may be conducted in facilities open to the public during the Activity. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue that part of the Activity, which involves the unsafe condition.
2. I FULLY UNDERSTAND that archery activities involve risks and dangers of BODILY INJURY, INCLUDING PERMANENT OR PARTIAL DISABILITY, PARALYSIS, OR DEATH OR OTHER HARM ("Risks").
3. I hereby agree that as organizer of this event I have/will use due diligence to ensure the archery range is secured and safe to avoid potential injury to participants and spectators and to avoid potential harm to the facility. I have taken the necessary steps to provide proof of insurance coverage for the venue if so required, and agree that all participants will sign the USA Archery waiver form prior to participation.
4.
